



IMPORTANT CROP INSURANCE INFORMATION

FIRST AND FINAL PLANT DATES

	<u>FIRST DAY</u>	<u>FINAL DAY</u>
Wheat	March 21	May 15
Corn/Sugar Beets.....	April 11	May 31
Soybeans	April 21	June 10
Dry Beans.....	April 26	June 10

*If you plant prior to the FIRST DAY, there is no replant coverage.
 *FINAL DAY dates are approximate; contact agent for your specific county.

*LATE PLANTING: Production guarantee is reduced 1% per day for each day planted after the final plant date, up to 25 days. Silage-only varieties of corn are uninsurable as grain.

HAIL/WIND DEADLINES

Production Plan Hail & Wind Products	June 1 or June 15, depending on company
Cash Discount for Hail/Wind Premium	August 15
Other Basic Hail Products	Effective time varies among companies

ACREAGE REPORT DEADLINE: JULY 15TH

ACRES & SHARE PERCENTAGES MUST BE CORRECT. In some cases, FSA certification may be used to verify your report. If, for any reason, FSA certification does not match how proceeds of crop will be distributed, please let us know.

PREVENTED PLANT

- Claims must be reported within 72 hours after planting is no longer deemed feasible during late planting period.
- Prevented plant acres must be listed on your FSA-578 forms.

REPLANT

- **Claim must be turned in prior to any replant activity.**
- 20 acres or 20% of the planted acres in the unit, whichever is less.
- AIP may determine if it is practical to replant up to the 10th day after the final plant date.
- No replant payment will be made on acreage initially planted prior to the earliest planting date.

CLAIMS

If you think you may have a loss, you must notify your AgQuest Agent:

- Within 72 hours of discovery, if a loss is anticipated on any unit.
- No later than 15 days after earliest of the following:
 - Damage to the insured crop on that unit
 - Harvest of the unit (within 15 days after harvest).

If you intend to commingle old grain with new grain, it requires bin measurement by an adjuster.

REMINDER: A timely notice of loss must be reported for any loss, including revenue losses. If you expect a revenue loss you must submit a notice of loss not later than 45 days after the date the harvest price is released. For more information, please call your local agent.
